This has now been rectified by implementing the Office 365 service to access NHS mail so that Users can successfully update their password from within Docman.
D10-5096		Bug	Auto-registration match on NHS number	The patient lookup in Docman will now use the NHS number to match a patient in PATCHS as part of the auto-registration process. If there is no NHS number to match the patient then the lookup will fall back to matching based on forename, surname & DOB.






