Due to this rejection message not being clear as to why the document was initially rejected we have now added a mandatory notes field. This field should

D10-2397	N/A	Change	Bit per pixel during conversion	To help reduce the number of documents rejected due to file size after conversion to TIF format we have now introduced 16bpp conversion. Three options are now available 4bpp, 16bpp and 32bpp.
D10-2398	N/A	Defect	Incorrect details carried through resending process	When using the update and resend functionality on the Connect console the document would pass through the OCR process and automatically fill out the required fields with data found on the physical document. Due to the document already being sent once, we now recapture the original data sent and provide the OCR data as a selectable option.
D10-2407	N/A	New Feature	Send a FHIR message to an endpoint: MH discharge sections not added on FHIR XML	During the sending of FHIR TOC message (XML), any mental health FHIR messages must include the MH discharge sections added during the TOC document creation. D10-2419	N/A	Bug	Resending API document to Mesh TPP site causes error	When resending an API document to a Mesh TPP site, the original file content when capturing was not populated. When posting the document an error would be thrown stopping the document from being posted. This has now been fixed and is working as intended.
D10-2447	N/A	Task	Change FHIR service library to .NET Standard & rename	The FHIR Service library naming was no longer applicable. Some files needed to be created so the model classes are separated into their own C# files, following standard convention. The library was also changed to .NET Standard instead of .NET Framework.
