D10-1992	N/A	New Feature	Sending to non FHIR organisations	A new feature has been added to the FHIR functionality and now allows user to send TOC Mental Health & E-Discharge FHIR documents to non-FHIR receiving organisations (DM7, DM10 & MESH endpoints) and provides the FHIR document in a human readable format.
D10-2219	N/A	New Feature	Capture e-discharge/mh-discharge - Allow search for Care Setting Type when creating document	This new feature adds the ability to choose a Correspondence Care setting type when creating a TOC FHIR document in Connect. A user can now search SNOMED codes using a SNOMED browser and select a corresponding service.
D10-2228	N/A	Change	Alter current archiving to exclude any FHIR documents	This change alters the current archiving process to exclude any successfully posted FHIR documents that were created using Connect.

D10-2414	N/A	Bug	Blank page when capturing with no Spine settings saved	A blank page would be presented when attempting to capture and post a document in Connect console. This was due to no Spine settings being configured.
D10-2468	N/A	New Feature	FHIR TOC: Allow selection of allergies from a picker	This feature allows users to select allergies when creating a TOC FHIR document in Connect. Users can now select one or multiple allergies from a list using either code or term search.
D10-2469	N/A	New Feature	Allow section of diagnosis from a picker	This feature allows the selection of diagnosis when creating a TOC FHIR

				document in Connect. Users can now select a diagnosis from a list using either code or term search.
D10-2471	N/A	Change	Allow adding more than one diagnosis	This change amends the diagnosis selection by allowing user to select multiple diagnosis if required.
D10-2641	N/A	Bug	Allergies are getting added to Diagnosis section	When adding allergies using the allergy selector, the allergies were also being added to the diagnosis section. A fix has now been implemented and the allergies now only show under the allergies section.
D10-2642	N/A	Change	Add better styling to HTML FHIR documents	This change adds better styling to the FHIR documents sent to non-FHIR organisations so that users can easily identify the content and information for patients.
D10-2647	N/A	Task	FHIR investigation – test attachments	An investigation task was added to the sprint to test the sending of attachments and determine whether documents could be added to a full FHIR document. The tests determined that attachments need to be attached to the relevant sections of a FHIR document.
D10-2649	N/A	Bug	112 Hotfix – Read-only database needs to be configurable	The read-only database connection that was previously used for document counts and dashboard was hard-coded to use the current database connection with port +1. In AWS this is not possible as we do not use different ports for connections and therefore needed to be configurable. This has now been resolved in Connect 112 allowing the document counts and dashboards to work once again.
D10-2719	N/A	Bug	FHIR Branch - unable to use MESH processor in ConnectBot	An issue was found when testing a full FHIR document flow, when the documents reached the MESH processor it wouldn't process any MESH responses. This has now been rectified and all MESH responses are processed as expected.
D10-2727	N/A	Bug	FHIR Branch – NDR Mesh Response is not rejecting documents	When an Emis Mesh document receives an NDR response, MeshDownloader collects the message and MeshProcessor finds it from the queue but does not use it Reject the document. A fix has been applied and now rejects the document as expected based on the response.

D10-2749	N/A	Bug	FHIR – Unable to post any FHIR documents	When posting a FHIR document a blank page and an error were presented. A fix has been applied and documents now post as expected.
