Overview

Docman 75500.47 contains two defect fixes, one related to multiple ReportRunner.exe's causing backup issue and the other, a defect related to the address book.



75500.47 Changes

This release contains the following changes:

DEDT-499	21876329	Defect	Unable to add to address book	Users were unable to update and add new items to the address book in Docman 7. When doing so users would receive a validation prompt stating "No valid DOB format". This no longer occurs, and any updates or newly added items now save as expected.
DEDT-508	21906876	Defect	Report Runner Issue in 75500.43	When the backup service (DME7_BackupSrv.exe) was running, it was observed that multiple ReportRunner.exe's were being created every 4 minutes which then cause the MySQL service to crash. This issue was not replicable when testing internal however restrictions have now been put in place to prevent unnecessary calling of report runner during the Docman service-based auto backup. Regression testing confirmed that current backup service continued to work with the restrictions in place.
