D10-4909	21824415	Defect	Pre-defined outcome is being randomly selected when the User selects Custom Outcome	When a User works on a Task review, a pre-defined outcome from the window behind the custom outcome box is randomly being added to the task as well as the custom outcome. A solution has now implemented so that if the User clicks on the ok button, the background window with the pre-defined outcomes is disabled.
D10-5016	21771043	Defect	When merge letters are created, a copy is being placed in Capture and Filing "Not in a Folder"	When creating a merge letter, if a User presses the back button on the browser to cancel out of the process, a copy was being added to "Not in a Folder" in the Capture and Filing screen. A fix has now been implemented so that if a User presses the back button to cancel out of the Create Merge Letter screen, any copy added to "Not in a Folder" will automatically be deleted.
D10-5535	21927822	Small Change Enhancement	eRS Collection Failed – Error Collecting Roles	Previously if sites had a certificate that requires a password, any attempt to run an e-RS collection in RMS would result in an error. A new field has been added to the eRS configuration settings within Docman RMS for Users to enter a certificate password if required, resolving this issue.

D10-5452		Feature	Patient Facing Services Update attachment call to log the Document ID	The Document ID will now be included in the logs when the Update attachment API call is made. This is to ensure that the Support desk can investigate issues more effectively if required.
D10-5289	21955560	Defect	Open in EmisWeb gets stuck on redirect to landing page	An issue was identified when Docman re-directs Users to another page but gets stuck. This was highlighted when an action was performed using PATCHS. A fix has now been implemented to resolve this issue.
D10-5308	21957981 / 21961866	Defect	Patient Facing Services Editing Metadata on a document prevents you selecting visibility in tasks	<p>When a User edits tags on a filed document and then goes to Tasks to set the visibility of the document the option to set its visibility is marked as unavailable. A fix has now been implemented so that the option to set the document visibility will be available in such a scenario</p> <p>Also, when editing a filed document & added a tag to a document which has already had its PFS visibility set, pressing Save throws an error. The issue was fix as part of fixing 21957981.</p>
D10-5348	21962217	Defect	Patient Facing Services - Updating visibility in tasks hangs, allowing Users to select options twice	When setting the visibility of a document as part of a Task review, Users can choose to make it visible or not visible to Patient Facing Services. Once a User selects an option, the page will load. During this time, it was possible for Users to select again whether to make the document visibility or not visibility. To prevent the User from setting the document visibility twice the options will now be disabled upon selecting an action.
D10-5482	21984531	Small change enhancement	Failed Visibility calls not included in audit	A number of API calls had failed due to a result from the EMIS API and these failures had not been stored in the audit table in the

				database. Additional logging and auditing has now been added around the PFS functionality.
D10-5212	21991816	Small change enhancement	Verbose logging not capturing all events	<p>A discrepancy was identified between data shown in the audit tables and in the data logs when Verbose logging was turned on. Verbose logging was not capturing all events. The same fix outlined in the above issue was also applied here to improve auditing and logging around the PFS functionality.</p> <p>Moreover, if there are documents that the Desktop App has not finished sending to the clinical system, Users will be notified that they cannot shut down the Desktop App until this process has completed.</p>
