DCMC- 333	N/A	New Feature	Ability to resolve rejections via the API	A new API call has been added to the Connect API that allows customers to resolve individual rejected documents. This new API can be found using the following link: <u>Docman Connect API</u> .
DCMC- 1038	N/A	New Feature	New PEPR endpoint using patient reference to retrieve document and metadata	Due to the below change, a new API call was needed to account for the patient reference. A new API has been created which now allows PEPR to request a patient reference and the system will now return the document and metadate.
DCMC- 1039	N/A	Change	Replace patient ID with patient ref in /task-updates endpoint	A change has been made to the Task Updates PEPR API call so that the patient reference is returned instead of the patient ID.

DCMC-916	N/A	Bug	FHIR - API Docs not showing preview	Due to a 3rd party component in Connect, any FHIR document previews in html format were not visible in the Connect console. A fix has now been added to the console so the html documents can be previewed in a similar way to other file types.
DCMC-933	22041787	Defect	Connect Sender Filter Changing	A defect was noticed when using the filtering in the document list. When setting a sender organisation in the document list filter and applying the filter, the organisation sometimes changed. e.g. HUB52 to HUB520 This was caused by the organisation filter results being order by description instead of organisation code. A fix has now been applied and this issue is now resolved.
DCMC-963	DGP-I-246	Change	Option to have "Colour Required" ticked by default	A customer change was pulled from the Ideas portal which requested that the 'Colour Required' option on the capture console was ticked by default. This idea has now been implemented and can be configured at organisation level against any sending organisation.
DCMC-703	21929039	Defect	Source Group on Connect not working	When using the source group filter on the document list, PCTI users could see a 'Loading Failed' message. This was caused by the Source group dropdown values only being populated in the PCTI user had the 'Manage All Users' user role/feature. A clause was removed from the controller action and this issue no longer occurs when the 'Manage All Users' role is removed.
DCMC-766	N/A	New Feature	FHIR Audit when a user views TOC document or downloads document	A new feature has been added to the FHIR console functionality which creates an audit entry against a FHIR document when a user views or download a document from the Connect console. In the document timeline, you should now see the UserID and Username against these new entries.



DCMC-917	22023871	Defect	Cannot update and resend rejected document sent originally through the API	When attempting to Update and Resend and rejected inbound API document from the console with a REJ01 or REJ02 reason, users received an orange error banner. This was caused by non-verified whitespace/empty string and a fix has now been applied.
DCMC-988	22056438	Defect	Connect password reset issues	Some users needing a password reset were not receiving the password reset email upon request. This was caused by a missing paragraph tag in the body of the email. This has now been re-added and emails should now be received by users requesting a password reset.
DCMC-998	22063034	Defect	Cannot create a group called Radiology	A defect has been raised due to users being unable to create new groups which a description which has already been created, unless another word followed. A fix has been implemented and multiple organisations can now create new groups using the same name.

A locking process has now been added to any documents being collected and will



				only unlock once the collector has fully complete.
