This release contains sprints 157 and 158 and includes the following:

- Workaround for NHS mail sender filters failing to collect from NHS mail.
- Change to NHS mail WebAPI url.
- Change to Docman 10 endpoint document flow for PDF documents.
- Fix for group name field to save any groups with 50+ characters
- Fix for Docman 7 endpoints failing to collect from Connect.

Although this release may include tickets relating to FHIR, FHIR is not yet available to customers.

DCMC-713	N/A	Bug	Documents in list cannot be opened by clicking blank space	A bug was found when logging in as a sending user, the document list rows were no longer clickable as they once were. A fix has been applied and the document details page can now be accessed by clicking the document row.
DCMC-1136	22108588	Defect	Documents showing as non-previewable	An issue was identified on Connect where when a NHS email had attachment with file type which is not in acceptance list, the email was moved to processed folder. A change has been made to amend this functionality and any emails with documents that are not in the acceptance list are now moved to the unprocessed folder, ready to be manually dealt with by the practice.
DCMC-1139	N/A	Change	Allow documents stuck in conversion to be rejected	When a document fails conversion, if the error cannot be handled then the document can remain stuck until manual intervention. A change has been made to allow documents stuck in conversion to be rejected back to the Sending organisation. This in this state can be rejected by PCTI admin users only.

DCMC-778	21994548	Defect	NHS Mail Sender Filter Issue	A change was made to NHS mail emails by Accenture. After doing so the sender filter for NHS mail collections failed to filter, and therefore stopped these types of NHS mail collections. A workaround has been put in place to first perform a partial search on the mailbox, then from the results perform a full matching search based on the configured sender filters.
DCMC-1140	N/A	Task	156 Regression Testing	Placeholder for regression testing.
DCMC-1573	N/A	Task	157 Automation Testing	Placeholder for automation testing.
DCMC-1587	N/A	Bug	Incorrect NHS Mail URL in WebAPI	An issue was found when updating NHS mail password, when doing so in Docman 10 the requests were being sent to the old URL. This URL has now ben updated allowing any recent failed collections to run.
DCMC-1610	N/A	Task	Zephyr Admin	Ticket used for regression suite admin work.
DCMC-903	22027553	Defect	Tif Conversion Failed. File size too big.	When sending documents to Docman 10 endpoints, if the document was converted to TIF then sometimes the file would exceed the minimum file size limit. If the document was originally in PDF format, Connect will now attempt to convert to TIF, if the document exceeds the file size limit then Connect will send the original PDF instead.
DCMC-1600	N/A	Task	158 Automation Testing	Placeholder for automation testing.
DCMC-1623	22173890	Defect	Connect Collections on DM7 are all failing to download documents from Connect	A code change was made as part of a technical efficiency change, this caused Docman 7 collections on Connect to fail and return an incorrect value. This has now been resolved and was patched into the 156 release.
DCMC-1641	22098478	Defect	Console truncating group names over 50 characters	A change was implanted in a previous release to allow Group names with 50+ characters (max 255). A script was missing from the release which should have increased the size of the database table. This script has now been run and the Group names that exceed 50+ characters can now be saved successfully. Fixed as part of the 156 release.
