## Defect Fixes

### **NHS Mail Collections Failing due to Refresh Flag**

**Salesforce Case** – 22150817

Some NHS mail collections were failing upon setup in Connect. This was caused by the NHS mail refresh functionality which was previously used when NHS mailboxes were migrating to Office365. This functionality has now been removed from Connect and new NHS mail collections are now setup with the correct 365 URL.

### **Documents Received in an Unreadable Format**

**Salesforce Case** – 22229942

**Patched in** – Docman Connect 158

Documents being sent to Connect from Carenotes were being displayed as raw html and was not readable for the end user. This issue was caused by an unnoticed merge during the release build process where the conversion functionality was removed in the version 160 release. A hotfix to version 158 has been applied resolving the formatting problem and this fix has also been applied to the 160 release.

Restrictions added to NHS mail collections restricting DM10 users from using invalid characters in the NHS mail passwords. This change has been made to align with the office 365 password policy.
