# What's New?

**NEW****File size displayed on document details**

The document file size is now displayed in the document details for any document in the Connect console. This will display the file size of the document before conversion and once converted to the appropriate document format for the destination organisation, the file size will then be based on conversion output.

**NEW****API – Return a list of documents status changes**

We have added a new API call to the Connect REST API which will return a list of document status changes over a specified time period. This API call will only provide updates on documents changed to the following statuses:

- Accepted
- Delivered
- Rejected
- Rejection Resolved

**NEW****Original ODS auto-populate upon resending**

A new feature has been added to auto-populate the destination organisation ODS code when resending a rejected document via the Connect console. Effected rejection reasons include REJ03, REJ04, REJ06.

**API** **File Content is invalid**

JSON messages sent over the API with invalid file content were causing internal server errors and not providing a suitable response back to the Sending Organisation. The exception is now captured, and any messages sent with invalid file content will now receive a “DC01.31 – File Content Missing or Invalid” response.

## Defect Fixes

**FIX** **Issue collecting XX2 files from NHSmail****Salesforce Case** – 22108588

.XX2 documents sent via NHS mail were being rejected as an invalid file type by Connect. .XX2 documents have now been added to the list of valid file types for Connect and any documents in this format will now be collected and processed appropriately.

**FIX** **Chrome automatic suggestions covers the calendar****Salesforce Case** – 22135068

A fix has been applied to Connect for the Google Chrome browser. An issue was identified where automatic Chrome suggestions would cover the calendar in the document list filter. This should no longer occur which allows users affected by this issue to use the date selection functionality as intended.

**FIX****NHS Mail Sender Filter – Follow on****Salesforce Case – 21994548**

A fix for the NHS mail sender filters issue was released in 2.158.0. Whilst this fix resolved the issue for the majority of sites, a small number of sites using this functionality were still impacted. Another fix has now been applied to run an exact match on the partial match results applied in the 2.158.0 release. Although this does not fix the root cause of the issues caused by a change to NHS mail in March 2021, this workaround should allow the NHS mail sender filter functionality to work once again.

**FIX****MRN is not showing on export****Salesforce Case – 22249705**

A defect was logged due to the MRN value not showing in the appropriate column in the document list export. A fix has been applied so that the MRN value found in the document list export reflects the MRN value found in the document details section.

## Background Changes

**ADVICE****CSV Export linefeed (lf) characters**

Some values in the Document List CSV export contained double quotes or line-breaks which were not enclosed in double quotes, this caused formatting issues when viewing the exported CSV file in MS Excel. A change has been made to include the missing in-line feed characters check which should resolve the formatting issues when viewing in Excel.
