DEDT-614	21999168	Defect	Docman issue creating a new user by copying from Clinical system	When creating a new user from a Vision user, admin users would receive a system error. The system error was caused by the system missing the user Id and username from the clinical system. This has now been fixed by adding the missing details when creating a user by using the associated clinical user.
DEDT-615	N/A	Bug	New user is created from a copy, pop-up says user already exist	When creating a new user from a copy of a user, changing the details and then saving. A pop-up message would appear stating "A user with a login ***** already exists". This occurred because the saving of the copy happened as soon as the copy was created. A fix has now been implemented to stop saving copied users upon creation and only save when the user clicks the "Save" button.
DEDT-491	21869682	Defect	Docman Exports	When running a patient export, after the export completes successfully, all documents should be removed as part of the export procedure. The removal of all documents was failing due to incorrect parameters being passed to the query used. This has now been resolved and all documents should now be removed as expected.
