DEDT-612	21876779	Defect	Moving multiple documents in Docman is forcing users to select a single folder in new location.	When moving multiple documents from specific folders in Docman to a new patient, Docman was prompting the user to select a new folder to move the documents to. This has now been amended so that upon moving the documents, they will remain in the original folders that the documents were previously filed to.
DEDT-539	21954833	Small Enhancement	EMIS PCS post merge issues opening XXX files	<p>After two EMIS PCS sites had merged, users found that when opening the documents from within Docman, it would open up the wrong patient and documents. The reason for this is because during a site merge the document IDs are re-numbered which caused a mismatch of documents between Docman and EMIS. A change has now been made so that when opening documents that can be found in EMIS but no longer exist in Docman (or documents associated with the wrong patient), users will now see the following prompt:</p> <p>“Document could not be found for the current patient. Opening the current patient record.”</p> <p>If you click “Ok” to the above prompt it will then open the current patient with the first document in document viewer selected.</p> <p>If lightweight viewer is enabled, then the document will be displayed but when you click View in Docman you will see the same prompt.</p>
DEDT-167	22032648	Bug	Issue with clear all recipients when using broadcast workflow	A previous fix was applied to Docman 75500 which added to stop the ability to create an orphan broadcast workflow. The previous fix was not the intended fix and this had to be reworked. Broadcast workflow no longer have the option to “Clear all Recipients” as a broadcast always needs at least one user assigned. Instead users will now only see the “Remove Recipient” option, users can

				remove all users but one so that orphan workflows are no longer possible.
