D10-7583	22847024	Defect	Error when changing patient details.	Patient details could not be edited for already filed documents through the 'filing details' component. This has been fixed.
D10-7171	22857319	Defect	Filing to Library	Depending on some configurable options, the 'File to Library' functionality was not working correctly. This has now been fixed.
D10-7633	22858319	Defect	Editing reviewers on workflow	The RMS system was getting stuck if an attempt to edit a document's reviewers was made. We have fixed this issue for group reviewers.
D10-7631	22857160	Defect	Issue adding new patients	Double clicking too quickly on the 'Add New Patient' functionality would break the next stage of the process and the user would not be able to move on after adding patient details. The 'Add New Patient' button is now removed after being clicked once, so this cannot happen again.
