What's New?

- When posting documents, the field to select 'NHS Number' has now been renamed to 'NHS/CHI number' to facilitate sending to practices in Scotland .

- When filtering the Document List using the drop-down arrow, multiple Rejection types can now be selected within the 'Information' field.
-

- The REJ06 document rejection reason is no longer free-text. However an optional field for additional free-text notes has been added to this rejection type with a limit of 150 characters.
-

- Within the Document List, instead of being able to click anywhere on an entire row to view the respective document, now only the 'ID' is a clickable field for senders or 'GUID' within the collection console (Now also highlighted in [blue](#) and underlined). This will prevent accidental navigation to the document when trying to highlight information from the row. Users can still open the document using the button on the right-hand side of the row and selecting 'View Details'.

Fixes

- Fixed a bug in which users were not receiving their 'Retrieve User Name' email, when clicking 'Can't access your account?' at the login screen, if the Organisations had a short Org Code (the original problem was raised for a 3 character Org Code).
