- For RMS (Enhancements), Referral Reports are now only visible to users logged in under the Privacy Officer and Administrator roles.
- Added 'Enter Application/Client ID' and 'Enter Client Secret' to the screen used for resetting NHS mail passwords to facilitate upcoming changes to Outlook basic-authentication deprecation.

- Previously when setting up a weblink, capitalised characters were replaced with lower-case characters upon saving, this is now fixed and will retain capitalised letters.
