# Background Changes

## BUG

- Fixed a bug where running the `/api/document/status-update` call was only receiving a response when there are no document updates within the 'datetimeinteger' range, otherwise received a 500 error.
- Fixed a bug where sending to a TPP destination failed if sent to an organisation where the ODS code began with a lower-case letter.
- Fixed a bug where using the 'resend source update errors' caused the documents to be sent back to the Hub without a rejection reason.
