## What's New?

### NEW

- Added the ability to capture .odt documents, with full annotation & stamp compatibility.
- Now when linking Docman 10 users to EMIS, the returned list only contains active EMIS accounts.
- The Intellisense Template report now contains an additional field, displaying if the template is active or deleted.

### Fixes

- Improved functionality when switching EMIS organisations with the Docman Desktop App running – some information from the previous organisation was retained causing Single-sign-on to look for the user from the previous site, thus forwarding the user to 'site down' page until the desktop app was restarted.
- Fixed an RMS10 issue where the Desktop App wasn't updating automatically.
- Fixed an internal issue where organisation go-live dates would display incorrectly due to formatting.
- Fixed an issue where clicking 'Save' at the point of filing a document in quick succession could create multiple 'Document Refiled' entries within the Document timeline.
- Rectified an RMS10 issue which caused the 'ViewReferralReport' feature to behave incorrectly in the way it permitted/restricted accounts access to Referral Reports.
