What's New?

NEW

- Added the new method of authenticating NHS mailboxes. In all parts of the application where users would usually input NHS mail password, a blue button will now be present with the text 'Click here to consent', upon clicking this button users will be directed to the NHS mail login portal. Inputting the correct NHS mail details (corresponding with the original 'Click here to consent' button), will automatically allow our system to continue collection of email documents from that inbox.
- Added 'Job Role' selection which needs to be assigned to all users mandatorily. Upon logging in users will have to select from the list which entry best fits their role within the practice. This is to assist us with future improvements.
- The use of emoji and non-alphanumeric characters is now prohibited within task comments due to some compatibility issues causing the comment to display blank.
- Adding 'Additional Notes' is now prohibited when rejecting documents sent from our Docman HUB systems. The field will be greyed out with a notice that displays 'Notes cannot be added when rejecting to senders of this type'.
- (RMS10) Increased the character limit of the 'Outcome' field to 511 characters.
