## What's New?

### NEW

- When filtering the Document List by Source User, if the Source User is invalid/non-existent, a message will now display 'User not found' instead of just allowing the filter to run and return zero documents.
- A new option has been added for Document Senders, now able to specify the 'author' of a document.
- 'Continue' button is now highlighted more clearly when capturing documents.
- After clicking 'Post Document' users can now see more clearly that the process is working. Previously clicking this could appear as though nothing was happening, it is now greyed out displaying 'Posting document...'

### Fixes

- Fixed an internal issue which could cause the Document List to not display correctly, due to scaling, when a specific type of HTML document rejection error was present.
- Fixed an issue where incorrect 'original file size' was displayed in the Document Details page when multiple documents are merged and sent to a destination.
- Improved performance on filtering & exporting document lists, some timeouts were reported for larger organisations. Time-outs should no longer occur.
