- Stamping and annotating documents will now create entries within the Document Timeline and be auditable within relative reports.
- We've added a layer of security when users change their own passwords or update their own email addresses. A user will be forced to reauthenticate at this point by entering their current password.
- We've added an additional layer of security when a password or email address is changed against a Docman account, the previously associated email address will receive a notification upon email change, or the current email address will receive a notification for password changes.

Defect Fixes

FIXES

- Fixed an issue within RMS where the Task Tracker report would be slow to load or sometimes timeout when selecting certain filters or running the report.

- Fixed an issue within RMS where ERS attachments were converted to 1 bit (black and white) when merged with the summary document, now the conversion will retain the colour.

- Fixed an issue which caused documents to be added to 'Not in a folder' even if a user had selected a different folder to capture to.

- Fixed an issue where the Keyword Match Type field would not save when creating or editing Intellisense Templates.
Case: 23261427
- Fixed an issue where the application would attempt to use Single Sign-On (SSO) even when the feature was disabled at an organisation level. Now if SSO is disabled, the application will skip the SSO check and navigate directly to the user login screen.

- Fixed an issue where all pre-populated fields were not retained when changing any other field within My Profile>User Profile and also Settings>Users
