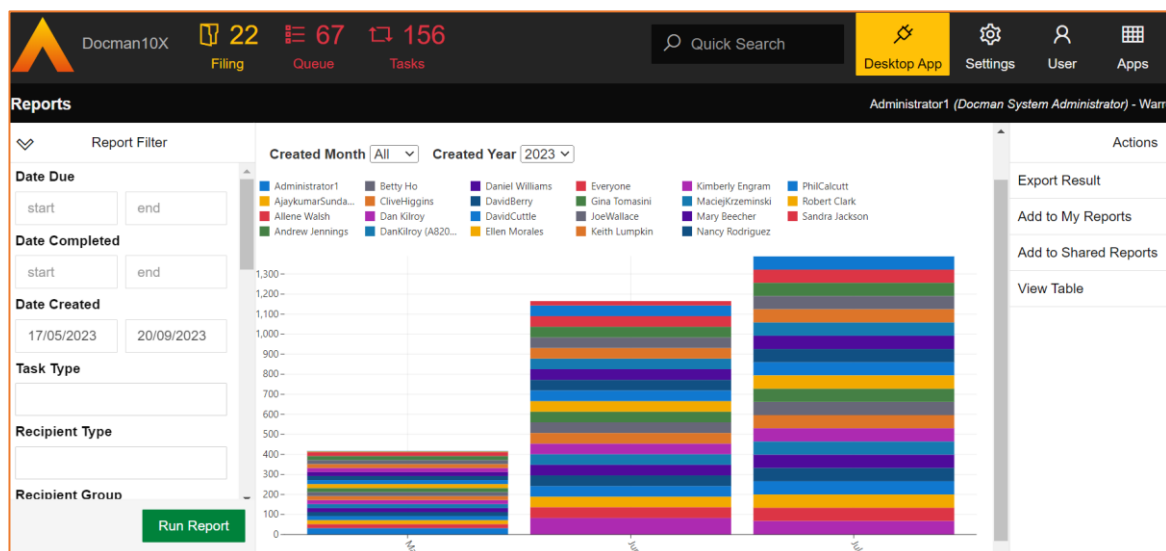
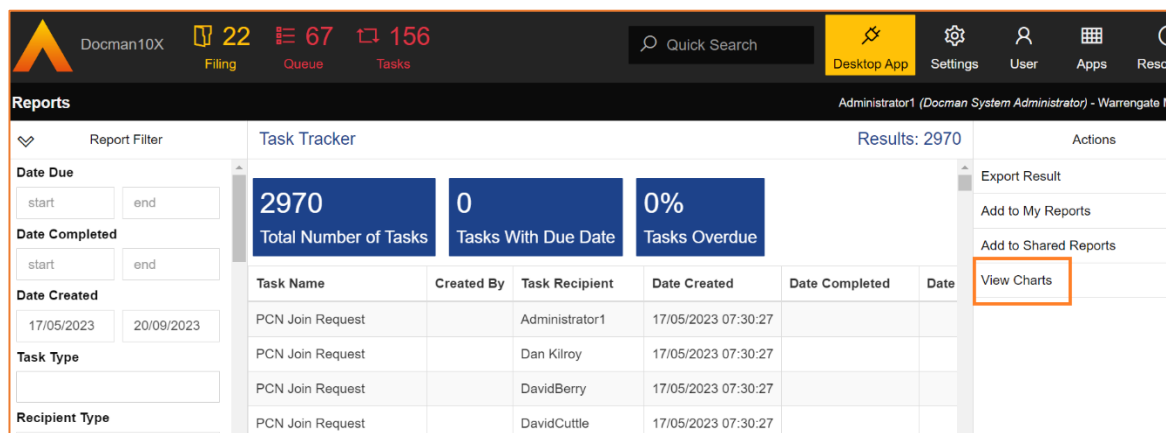
NEW Charts

Number of Tasks (by Recipient)

This chart breaks down tasks created, by the recipient user they were created for, mapped out by monthly view or yearly view. It will enable you to better assess workload across the user base.

This chart can be accessed via the “View Chart” button on the existing Task Tracker report. The Chart results will reflect the Report search that has already been run:



Documents Received (by Input Source)

This chart breaks down documents received by input source (e.g Scanned, API etc), mapped out by monthly view or yearly view. It will enable you to better assess trends in document receipt numbers and the methods with which they are being sent.

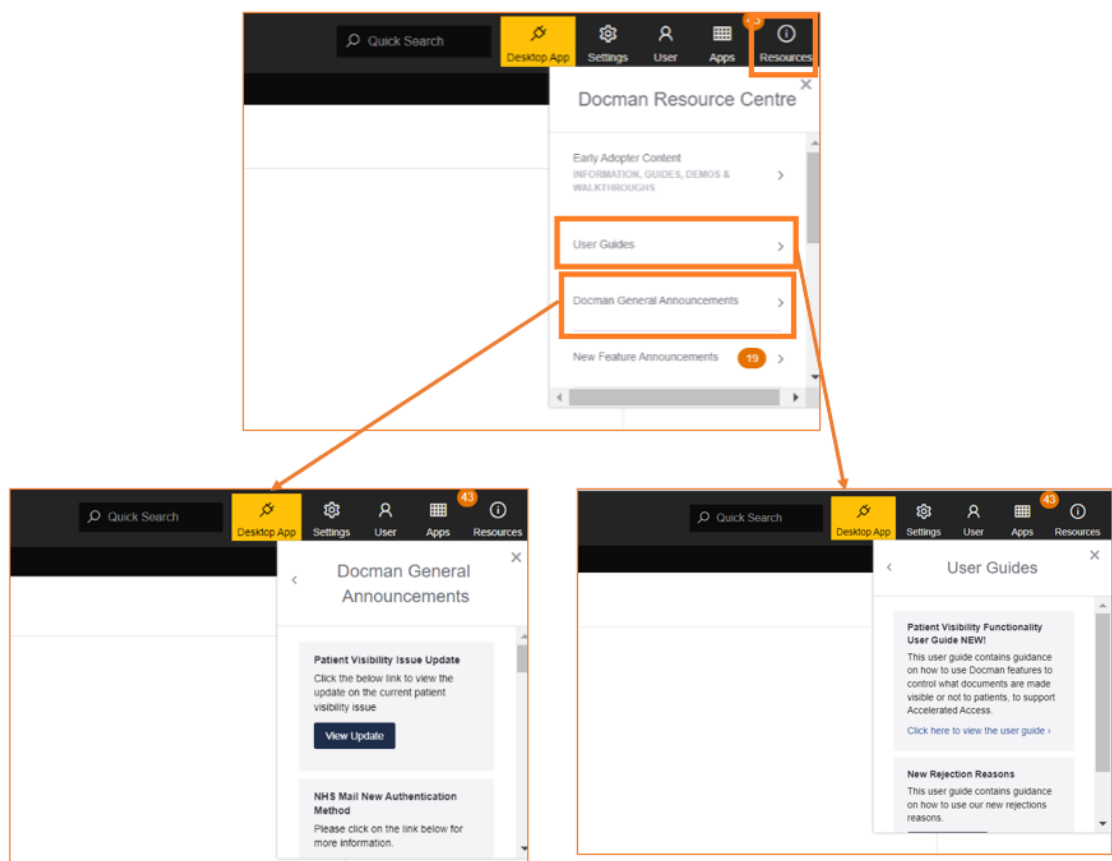
