- The text "Urgent Treatment Centre" within a document will now be detected as a department and suggested.
- Fixed an issue where logging in as a CCG user and navigating to another page under 'Sending' was causing organisation data to not display.
- Now filtering documents by the 'REJ06' rejection code will return all REJ06 rejected documents, ignoring the different custom reasons.
