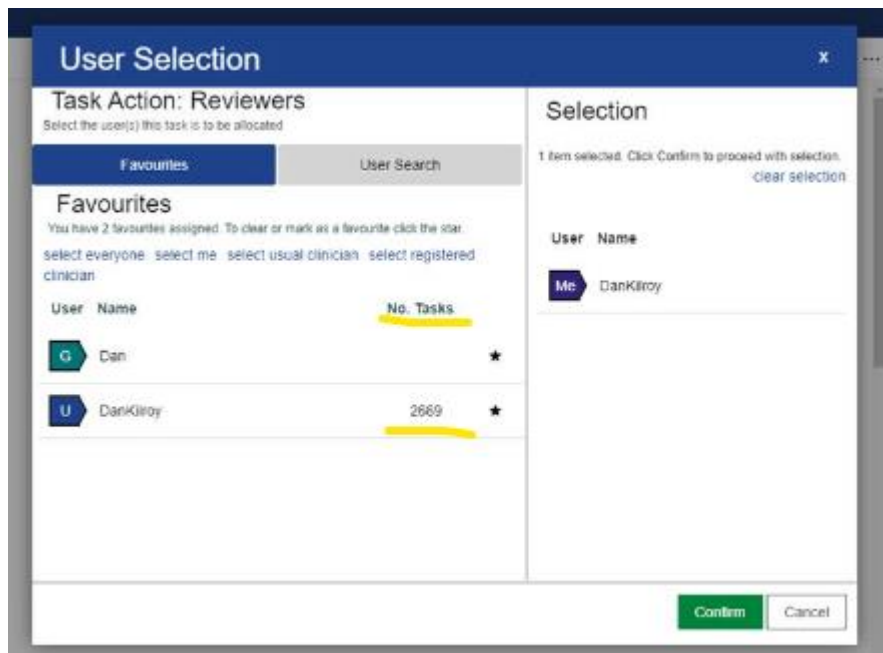
What's New?

UPDATES

- **Task Allocation – Number Of Tasks**

A new feature has been added to the Task Allocation User Selection page. A Number Of Tasks (No. Tasks) column gives visibility of the number of tasks each user has assigned. This will help to make informed decisions when allocating work based upon already allocated task workload.

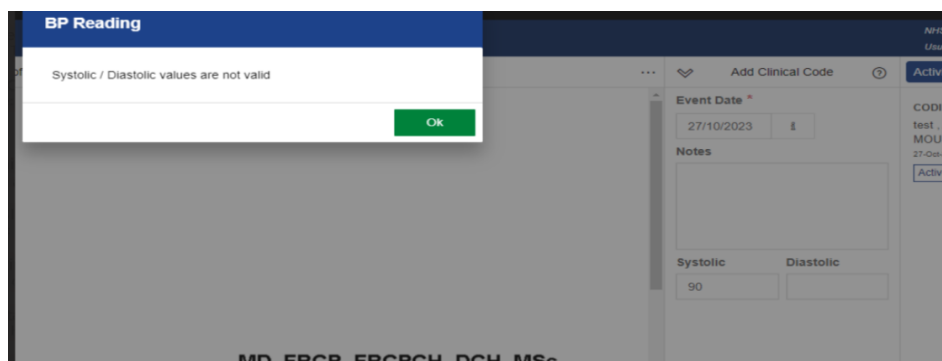
The No. Tasks column will only be populated when you allocate a task to an Individual. If you allocate a task to a Group then it will not be populated.



- **Validation added to Blood Pressure readings**

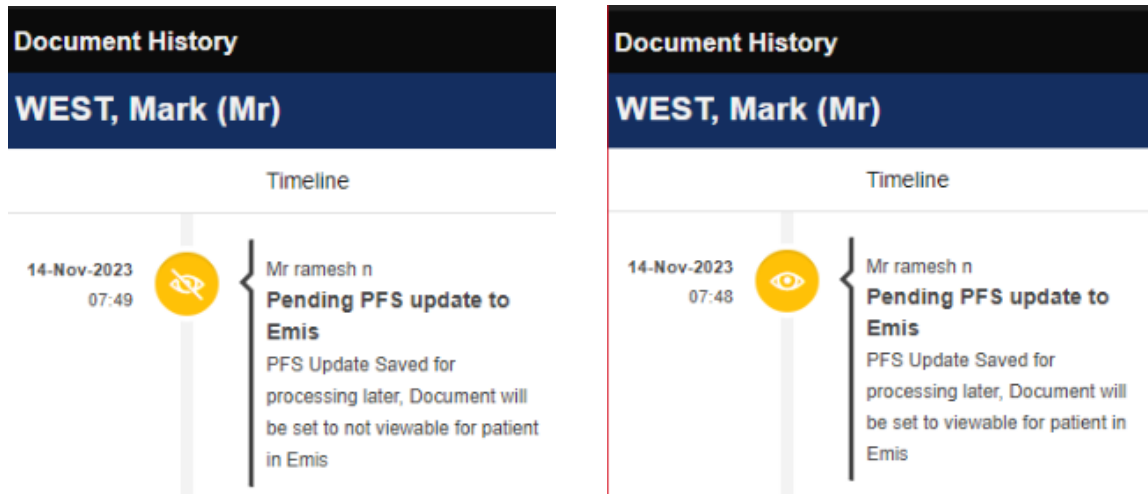
We've added validation to the Blood Pressure Readings data fields to prevent the entry of invalid data such as special characters. The fields allow the entry of numbers only.

We've also added validation to make sure that both the Diastolic and Systolic values are required for a Blood Pressure reading.



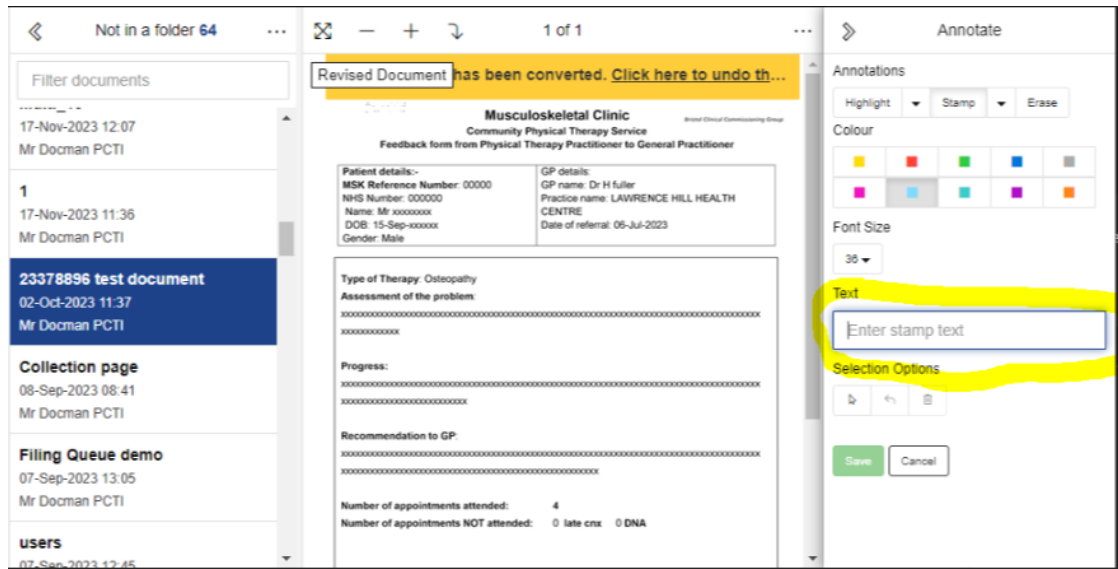
- **Patient Facing Services (PFS) updates to document history**

We've added more details to the Document History to make it clearer what the patient visibility status is for a document when the document is in a status of Pending PFS update to EMIS.



- **Update to Stamp Annotation**

We've added a limit of 50 characters to the stamp annotation. This will prevent large volumes of data being entered into the annotation field, ensuring the page runs efficiently.

New functionality has been added within the Patient Data area to lock the folder structure by default. This will introduce and ensure naming consistency is maintained across all Scottish Docman GP sites.
