(Reported by one site) When Online Services was selected for a document in Provisional state, the Online Services option was still showing as available.

Problem

Email (Subject - Docman 10 - Email address removed from account) is triggered and delivered to email box ("Password Reset Email Address") when fields are changed on My Profile/User Edit page. Changing fields should not trigger an email.
