D10-12079: Batch Bundle Request Issue

Problem: NSS are reporting a problem in Postman with the batch bundle request (to get the document counts for each of the folders, plus those not in a folder, plus the count of all documents). The request is giving a 403 Forbidden error of the format '<token>' not a valid key-value pair (missing equal-sign) in Authorization header: 'Bearer <token>'.

D10-12113: Remove active search parameter from DocumentReference searches

Problem: NSS reported bug from fix D10-11807. The active search parameter should be removed from DocumentReference searches.

D10-12114: Where the type is missing we should not receive a type element

Problem: NSS reported bug from feature in D10-11506. Remove type element when document is not in a folder and type is blank

D10-12162: Fix Diagnostics message for 400 Bad Request

Problem: Get Document References and Get Patients calls both have a blank diagnostics message, this will be updated to "Invalid Identifier"
