Filing Screen Text Amendments

Description

- The "Do No Share Document" tick box option has been renamed to "Do Not Share Document with Docman Share"
- The "Document Security" field which allows users to select whether to "Allow Access" or "Restrict Access" to the document has been renamed to "Document Access"



Filing Screen New Tool Tips

Description

- A new tooltip icon has been created to appear next to the newly renamed "Do Not Share
 Document with Docman Share" field. On hovering over the tooltip icon, the text reads
 "Docman Share makes documents available for viewing by other healthcare organisations
 outside of the patients registered practice"
- A new tooltip icon has been created to appear next to the "Internal Document Access" field. On hovering over the tooltip icon, the text reads "Use this feature to set who can access the document within the practice"



Filing Screen Additional Messages

Description

- A new warning message in red text has been created to appear beneath the "Create Review" dropdown menu. The warning message states "Online visibility to be set within tasks"
- The warning message will not appear if the user selects "No Review Required" from the "Create Review" dropdown menu.
- The warning message will appear when any other option from the "Create Review" dropdown menu is selected



Tasks Screen Amendments

Description

- The "Online Services" section of the Review Task has been moved higher up the page so that it appears underneath the "View in EMIS Web" section
- The buttons in the "Online Services" section have been renamed from "Allow viewing of this document" and "Prevent viewing of this document" to "Visible" and "Non-Visible"
- The UI of the buttons in the "Online Services" sections has been updated so that, when a user selects either "Visible" or "Non-Visible" the button they select will turn blue and the alternate option will be greyed out




Scotland – Cloud Enabler Tool and Orphan Docs Tool Links Added to Docman Apps page

Cloud Enabler application and Orphan Document Tool for Scotland NSS use have been added as links on the <u>Docman Apps</u> page, as per the screen shot below.






Workflow Template Options Wording

On the Workflow List Screens for Workflow templates, the status drop down text "Inactive/Obsolete" is amended to "Deleted/Obsolete" so that the purpose is clearer for users. (The highlighted item would have the text change)





Date picker defaults to 19nn

Description

When using date picker, the default has been changed to 20nn, unless the year input is less than the current year (in which case, 19nn will be used). This will make date selection quicker and more relevant.

Defect Fixes



Quick Steps involving multiple Clinical Codes is not displaying correctly

Case 23395217 | Internal reference D10-10146

Description

When using quickstep with multiple clinical codes on an Active Coding task, the same clinical code is displayed throughout the quickstep, instead of displaying the next sequential code. Please note, this was a visual issue only, the correct clinical codes were added into audit.



Improve Error Logging on Patient Synchronisation

Description

Site reported issue when synchronising EMIS patients into Docman 10, with error "Value cannot be Null". Additional logging has been provided to establish error when synchronising.



Enforce Clinical Offset Value for Merge Tool

Case 23691755 | Internal reference D10-12188

Description

A site encountered issues when merging with the incorrect offset number. The Merge tool has been updated so that the Clinical Offset Value is a required value and matches the value in the configuration.
